(Effective July 1, 2016)

General Service Single Phase (A9_F9)

Available to all year-round consumers for single-phase service where 50 kVA or less of transformer capacity is required. Service is subject to the rules and regulations of the Cooperative.

Facility Charge per month:	\$1.05 per day

(Sept. – May)	1500 kWh @ \$0.1130 per kWh Excess kWh @ \$0.0980 per kWh
(June – Aug.)	1500 kWh @ \$0.1280 per kWh Excess kWh @ \$0.1130 kWh

General Service Three Phase (B)

Available to all year-round consumers for three phase service where 50 kVA or less of transformer capacity is required. Service is subject to the rules and regulations of the Cooperative.

Facility Charge per month:	\$68.00

(Sept. – May)	1500 kWh @ \$0.1130 per kWh Excess kWh @ \$0.0980 per kWh
(June – Aug.)	1500 kWh @ \$0.1280 per kWh Excess kWh \$0.1130 per kWh

Interruptible Heating (DF)

Available to all consumers for separately metered controlled electric heating systems where electric service is also used for lighting and/or other purposes, and who agree to use the Cooperative's service for heating under the terms and conditions set forth by the Cooperative and other rules and regulations of the Cooperative.

Service under this rate schedule is limited to installations utilizing 4,000 watts or more of controlled electric heating load capable of heating the entire home at all expected temperatures.

Facility Charge per month:	\$4.00
Energy Charge per month:	
(Sept. – May)	\$0.0650 per kWh effective September 1, 2016 \$0.0700 per kWh effective May 1, 2017 \$0.0750 per kWh effective September 1, 2017
(June – Aug.)	\$0.0900 per kWh

Interruptible Storage Heating (ETS)

Available to all consumers for separately metered controlled electric heating systems where electric service is also used for lighting and/or other purposes, and who agree to use the Cooperative's service for heating under the terms and conditions set forth by the Cooperative and other rules and regulations of the Cooperative.

Service under this rate schedule is limited to installations utilizing 4,000 watts or more of controlled electric heating load capable of heating the entire home at all expected temperatures. Service will be controlled for 14 hours a day with an eight (8) hour recharge period at night and a two (2) hour recharge period during the day.

(June – Aug.)	\$0.0900 per kWh

Temporary General Single Phase Service (A9-T)

Available to all consumers for separately metered electric storage heating where electric service is also used for lighting and/or other purposes, and who agree to use the Cooperative's service for heating under the terms and conditions hereinafter set forth and other rules and regulations of the Cooperative. Temporary rate until the dual fuel meter is set and inspected by a Cooperative representative.
