Monthly photo submission deadlines are the last day of each month at 4 p.m. All photos submitted may be used in future cooperative member correspondence and/or displayed on the walls at Jackson Electric Cooperative.

Who May Submit Photos:

All members of Jackson Electric Cooperative.

Photos to Enter:

All photos must be taken in Jackson Electric Cooperative's service territory (Jackson, Eau Claire, Clark, Monroe, Trempealeau, and La Crosse counties) and submitted digitally. High resolution photos only. Please make sure the date stamp is not included on your photo.

Submitted photos can be in color or black and white. The photo should capture the seasons, wildlife, landscape, events, etc. of Jackson Electric's service territory. Please keep the photo as close to the original shot as possible.

Three photos per member per month will be accepted. The same member cannot win consecutive months.

How to Enter:

Please submit photographs to cblaken@jackelec.com in jpeg format, put in the subject line "PHOTO CONTEST". No photographs through the mail accepted. Digital photographs should be taken at the highest resolution possible.

By entering the contest, you grant JEC a royalty-free, perpetual, non-exclusive license to publicly display and reproduce the entry for future member publications, etc.

If you are having problems submitting photos, please check the file size of each photo. The maximum file size allowed for each photo is 5 MB.
