

Agricultural and Commercial

Agricultural and commercial members who install certain types of energy saving equipment and/or incorporate energy efficiency measures may qualify for custom rebates. Please contact our office for details.

Exhaust fan.....\$1/inch diameter
Circulation fan.....\$1/inch diameter
(Qualifications do apply on fans)

Dairy plate cooler/well water pre-cooler...\$500/unit
Dairy refrigeration heat recovery with electric backup.....\$300/unit
(Used with controlled electric water heater)

Low/zero energy livestock waterer.....\$50/unit
(500 watts or less, insulated tank)

Scroll refrigerator compressor.....\$30/HP
Variable frequency drive.....\$30/HP
(Minimum is 1 HP to qualify)

Audit Recommended Improvements

- Energy efficiency improvements must be recommendations from an audit arranged by Jackson Electric Cooperative or a cooperative approved partner. Please contact Jackson Electric for auditor verification.
- Rebate not to exceed 20% of the cost of energy efficiency improvements up to \$500. Cost can include material and professional labor. The cost of the audit cannot be included.
- Audit must be a comprehensive audit including a written report.
- Audit report must indicate the improvement will result in electrical or delivered fossil fuels reduction or efficiency.
- Each member account qualifies for only one of this incentive every five years, regardless of the number of audits performed and regardless of the number of measures implemented.

Appliances

All appliances must be Energy Star rated. To receive your rebate, complete and submit to our office the rebate form, along with a copy of your receipt or invoice of each item purchased, and the Energy Star label. Appliances must be installed on Jackson Electric Cooperative's service lines.

Clothes washer.....	\$75
Clothes dryer.....	\$75
Heat pump clothes dryer.....	\$50
Dishwasher.....	\$75
Dehumidifier.....	\$75
Refrigerator (min. of 10 cubic foot).....	\$75



Lighting

To receive a rebate, complete and submit to our office the rebate form, along with a copy of your receipt or invoice of each item purchased, and documentation showing number of lumens and number of bulbs per fixture, if applicable.



LED bulb (quantity less than 5 bulbs do not qualify).....	\$1/bulb
LED fixture.....	\$1/800 lumens in fixture
T5 fluorescent fixture.....	\$6/bulb in the fixture
T8 fluorescent fixture (replacement only).....	\$4/bulb in the fixture

Heat Pumps

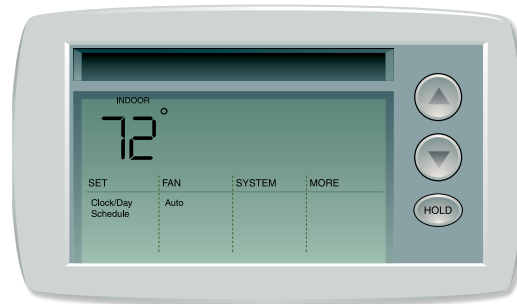
To receive a rebate, complete and submit the rebate form to our office, a copy of your receipt or invoice, the AHRI certificate, and documentation showing the equipment is installed and operating on Jackson Electric Cooperative's service lines.

Air source heat pump.....	\$625/ton
<small>(SEER 14+, HSPF 8.2+, or EER 11+)</small>	
Geothermal heat pump.....	\$400/ton
<small>(New units not allowed on Jackson Electric's load management program)</small>	
Variable speed blower motor.....	\$35/unit
<small>(New furnace only. Efficiency (AFUE) ≥ 95% and kWh/yr (Eae) ≤ 670 or variable speed as listed on the AHRI certificate)</small>	

Electric Heating

To receive a rebate, complete and submit the rebate form to our office, a copy of your receipt or invoice stating the size of the unit, and documentation showing the equipment is installed and operating on Jackson Electric Cooperative's service lines. Equipment must be connected to Jackson Electric Cooperative's load management receiver.

Electric boiler.....	\$25/kW
ETS room unit or furnace.....	\$25/kW



Water Heaters

Load management receiver must be installed to receive rebate (excludes heat pump water heaters). Electric water heaters must meet minimum efficiency standards to qualify for the rebate.



105-gallon Marathon purchased from Jackson Electric.....	\$400
100+ gallon purchased from another retailer.....	\$200
Heat pump water heater.....	\$300

Rebate Qualifications

- Rebates are not to exceed 20% of the cost of the efficiency equipment.
- New equipment must be purchased, installed, and operating (generating kWhs) in 2018.
- Installed new equipment must be on Jackson Electric Cooperative's lines. New equipment is subject to verification by a Jackson Electric representative.
- Rebates are in place through December 31, 2018, or until funds are depleted.
- Availability of rebates is subject to change without notice. Submit required documentation within 60 days of invoice date or no later than January 2, 2019, whichever comes first.
